## FEATURES:

- Twenty-One Flyers was incorporated in 1953.
- Aircraft is a Cessna Skyhawk (C-172M, 1976).
- Aircraft is equipped for IFR operation.
- Aircraft is located at Sikorsky Memorial Airport (KBDR) North Ramp, T Hanger 19C.
- Monthly meetings are open (3rd Wednesday of the month).
  - Meetings are held in the Sikorsky Memorial Airport Tower conference room at 7:00 PM unless otherwise directed. Open to the public.
- Flight reservations are made on-line through Schedule Master.
- Active membership is limited to 13 active members per aircraft.
- The aircraft investment is depreciated at 30% per annum on remaining balance (no annual assessment).
- Hangar investment is fully refundable pending a new member replacement upon leaving the club
- Only minimums on flight time are on weekends (2 hours, minimum, per weekend day, if the aircraft is signed out for the entire day).

## MEMBERSHIP RATES:

- Application Fee/Initiation:\$200.00 (subject to change; refundable if application not accepted)
- Aircraft Investment: \$2,000.00 (subject to Change)
- Hangar Investment: \$2,000.00 (subject to Change)
- Monthly Dues – based on total operating costs divided by number of active members (\$~100/month)
- Flight Rate per Tach Hour, Wet (adjusted periodically based on current price of fuel ~\$85.00/hour)
